This Amendment No. 5 to Schedule 13D amends certain Items of the Schedule 13D filed with the Securities and Exchange Commission on January 19, 2011, as amended on August 29, 2011, July 12, 2012, January 3, 2014 and July 27, 2016 to Schedule 13D (this "Amendment No. 5") is filed by Phillip Frost, M.D., Frost Gamma Investments Trust (the "Gamma Trust") and Phillip and Patricia Frost Philanthropic Foundation, Inc. ("Philanthropic Foundation", and collectively with Dr. Frost and Gamma Trust, the "Reporting Persons"), with respect to common stock, \$.001 par value per share ("Common Stock") of ChromaDex Corporation, a Delaware corporation (the "Issuer"). The principal executive offices of the Issuer are located at 10005 Muirlands Blvd Suite G, Irvine, CA 92618. Information regarding each of the reporting persons is set forth below.
