As part of the lawsuit, the parties agreed to a total release of all claims. The lawsuit was filed on April 21, 2011 in Clark County, Nevada, alleging, among other things, that the Company's Board of Directors did not have the power to designate series A and B preferred stock without amending the articles of incorporation. The complaint also alleged any such amendment would require shareholder approval and filing of a proxy statement.
