Explanation of Responses:

- (1) On July 9, 2007, the reporting person was granted an option to exercise 15,500 shares of common stock. The option vests equally in three annual installments beginning on July 9, 2008.
 - (2) On October 30, 2007, the reporting person was granted an option to exercise 12,000 shares of common stock. The option vests equally in three annual installments beginning on October 30, 2008.
 - (3) On April 14, 2008, the reporting person was granted an option to exercise 25,500 shares of Common Stock. The option vests equally in three annual installments beginning on April 14, 2009.
 - (4) On April 13, 2009, the reporting person was granted an option to exercise 40,000 shares of Common Stock. The option vests equally in five annual installments of 8,000 shares beginning on April 13, 2010.
 - (5) On April 19, 2010, the reporting person was granted an option to exercise 25,100 shares of Common Stock. The option vests in three annual installments of 8,366 shares on April 19, 2011, 8,367 shares on April 19, 2012 and 8,367 shares on April 19, 2013.
On April 19, 2010, the reporting person was granted 9,000 shares of Common Stock pursuant to a Restricted Stock Agreement. The
 - (6) shares are subject to forfeiture and are scheduled to vest as to one-third of the shares on each of April 19, 2011, April 19, 2012 and April 19, 2013, pursuant to the terms of the Restricted Stock Agreement.
On April 19, 2010, the reporting person was granted 7,200 shares of Common Stock pursuant to a Restricted Stock Agreement. All or a portion of the shares are subject to forfeiture based on pre-determined corporate financial performance criteria for fiscal year 2011.
 - (7) Following the completion of fiscal 2011, a determination will be made if the threshold financial performance criteria have been met or exceeded. If the threshold level of performance is not met, all of the Restricted Stock is forfeited. To the extent that the performance-based restrictions lapse as to some or all of the Restricted Stock, then the shares vest as follows: (i) one-third as of the date the performance-based restrictions lapse and (ii) one-third each on April 19, 2012 and April 19, 2013.
 - (8) This number includes restricted stock awards.
