On December 1, 2004, Blockbuster Inc. (Blockbuster) issued a press release confirming its willingness to increase the price it is willing to pay for shares of Hollywood Entertainment Corporation (Hollywood), subject to Hollywood's elimination of a standstill requirement currently preventing delivery of confirmatory information and Blockbuster's review of such confirmatory information. Any solicitation or offer to buy Hollywood's common stock will only be made, if at all, pursuant to an offer to purchase and related materials.
