On December 28 and 29, 2004, The Dallas Morning News, Video Business Magazine, USA Today and the Los Angeles Times released articles discussing the announcement by Blockbuster Inc. (Blockbuster), made in a press release issued December 28, 2004, that it intends to commence a cash tender offer by mid-January to purchase all of the outstanding shares of Hollywood Entertainment Corporation (Hollywood) for \$11.50 per share in cash if Blockbuster is unable to obtain substantial cooperation from Hollywood s Board of Directors that is likely to lead to an agreement for an acquisition of Hollywood by Blockbuster. The articles included information obtained from interviews with Edward B. Stead, Executive Vice President and General Counsel of Blockbuster.
