In connection therewith, Blockbuster entered into an amendment to the company's employment agreement with Mr. Stead to provide him with a lump sum severance payment of \$1,045,800. Mr. Stead's employment agreement is filed as an exhibit to Blockbuster's Form 10-K for the year ended December 31, 2001. The amendment to Mr. Stead's employment agreement effecting these changes is filed as Exhibit 10.1 hereto and is incorporated herein by reference.
