(the Corporation) approved an amendment to the Corporation s Bylaws fixing the number of directors that shall constitute the Board at eleven and requiring approval by the holders of at least 85% of the outstanding shares of common stock of the Corporation in order for stockholders to amend this provision at any time prior to consummation by the Corporation of a business combination (as described more fully in the Corporation s final prospectus, dated October 22, 2007, relating to its initial public offering). The Corporation s Bylaws, as amended by the Corporation s Board of Directors and effective on May 13, 2009, are attached hereto as Exhibit 3.1.
