On October 23, 2013, our Florida health plan, Molina Healthcare of Florida, Inc., and the Florida Agency for Health Care Administration (AHCA), agreed to a settlement under which our health plan will be awarded three contracts under the Florida Statewide Medicaid Managed Care Managed Medical Assistance (MMA) Invitation to Negotiate. Our Florida health plan will be awarded contracts for MMA Regions 7, 9, and 11, which includes the following counties: Miami-Dade, Orange, Palm Beach, Brevard, Osceola, St. Lucie, Seminole, Indian River, Martin, Okeechobee, and Monroe. The three contracts are expected to commence in the second or third quarter of 2014.
