On November 26, 2018, CVS Health Corporation (CVS Health) and Aetna Inc. (Aetna) received the final regulatory approval required for CVS Health to complete its acquisition of Aetna. The closing of the acquisition of Aetna is expected to occur on or about November 28, 2018, subject to the satisfaction of all other closing conditions.
