- (1) Restricted stock vesting in three equal annual installments on November 18 of 2006, 2007 and 2008.  
 Received in exchange for 6,600 shares of Fidelity National Financial ("FNF") restricted common stock pursuant to the Securities Exchange and Distribution Agreement ("SEDA") between FNF and Fidelity National Title Group, Inc. ("FNT") in connection with the spin-off of FNT. On the effective date of the spin-off, the closing price of FNF's common stock was \$20.70 per share, and the closing price of FNT's common stock was \$22.23 per share.
- (2) Includes 6915 shares of Fidelity National Title Group, Inc. ("FNT") restricted stock received as a dividend on the effective date of the FNT spin-off.
- (3) Option vest in three equal annual installments beginning September 10, 2005.
- (4) Received pursuant to the SEDA in connection with the spin-off of FNT in exchange for a stock option to acquire 34,392 shares of FNF common stock for \$25.3197 per share (prior to any anti-dilutive adjustment to the option to account for the spin-off of FNT).
