RSUs awarded pursuant to the fulfillment of Performance Share Units awarded last year. RSUs will vest in equal amounts over a two-year period beginning in 2009, and upon vesting, will be payable in Company stock (each RSU representing one share of Company stock). - (1) The SAR's were issued at the closing price of the Company's stock on February 20, 2008 (\$40.96).
