- (1) One-third of the restricted stock units granted to the reporting person on June 16, 2010 vested and such vested portion of the restricted stock units settled for shares of the Company's common stock.
- (2) One-third of the restricted stock units granted to the reporting person on June 17, 2009 vested and such vested portion of the restricted stock units settled for shares of the Company's common stock.

The restricted stock units will vest in three equal annual installments commencing on June 15, 2012. Vested shares will be delivered to the reporting person in three equal installments promptly after June 15, 2018, June 15, 2019 and June 15, 2020, respectively, at the reporting person's election to defer receipt of such shares.
- (8) The restricted stock units were issued pursuant to the Company's 2008 Stock Incentive Plan.
- (9) The remainder portion of the restricted stock units will vest in two equal annual installments on June 16, 2012 and June 16, 2013. Vested shares will be delivered to the reporting person promptly after the vesting date.
- (10) The remainder portion of the restricted stock units will vest on June 17, 2012. Vested shares will be delivered to the reporting person promptly after the vesting date.
