- As previously reported, on March 29, 2018, the reporting person received a grant of 288,660 time-based restricted stock units that vest
- (1) and settle in eight equal quarterly installments. The first vesting date occurred on June 1, 2018, resulting in the vesting and settlement of 36,082 shares of common stock, as shown in Table I. The remaining 252,578 restricted stock units are shown in Table II.
  - (2) Restricted stock units convert into common stock on a one-for-one basis.
  - (3) Shares withheld for payment of taxes upon vesting of restricted stock units in accordance with Rule 16b-3.
  - (4) Restricted stock units are settled in shares of the Company's common stock upon vesting.
