Furnished herewith as Exhibit 99.1 and incorporated by reference herein is a copy of a presentation being made by The Mosaic Company ("Mosaic") on September 16, 2015 at the Sixth Annual CRU-GPCA Fertilizer Convention in Festival City, Dubai, United Arab Emirates.

Additionally, as previously reported, Mosaic is negotiating possible settlements with the United States Environmental Protection Agency ("EPA"), the United States Department of Justice ("DOJ"), the Florida Department of Environmental Protection ("FDEP") and the Louisiana Department of Environmental Quality ("LDEQ") relating to allegations about Mosaic's management of hazardous waste at the Riverview, New Wales, Mulberry, Green Bay, South Pierce and Bartow facilities in Florida and its Faustina and Uncle Sam facilities in Louisiana. Mosaic believes that the negotiations are advancing toward completion, and that proposed settlement agreements may be filed with the appropriate United States District Courts in Florida and Louisiana in the next two months. Those courts must approve the settlement agreements for them to become effective.
