("Global Signal"), the Issuer and CCGS Holdings LLC. All outstanding Global Signal shares were exchanged for 1.61 shares of Issuer common stock or \$55.95 in cash, at each stockholder's election and subject to proration described in the Agreement. On 1/19/07, certain funds affiliated with Fortress entered into a Stock Purchase Agreement (the "SPA"), pursuant to which the Issuer agreed to purchase an aggregate of 11,042,424 shares of the Issuer's common stock for \$374,027,428.86. The closing of the transactions contemplated by the SPA is expected to occur on 1/26/07. Upon the consummation of such transactions, Mr. Edens and certain funds affiliated with Fortress will
