On August 14, 2012 the Company executed a memorialization of an Extension Agreement (effective July 15, 2012) with Mark A. Smith (MAS), the Company s Executive Chairman, President and General Counsel, pursuant to which MAS agreed to extend his service to Bion for 18 additional months through June 30, 2014, continue certain deferrals of cash compensation and other matters.
