- (1) Shares held in Grantor Retained Annuity Trust (GRAT) distributed according to terms of GRAT. On September 11, 2007 PACCAR declared a stock dividend of one additional share of common stock for every two shares of common stock payable October 9, 2007 to all holders of record of common stock on September 25, 2007. As a result of the stock dividend the Trust received 43,301 additional shares of PACCAR common stock. The Trust received \$28.52 for a fractional share valued as of October 9, 2007.
- (2) Restricted stock awarded under PACCAR Restricted Stock and Deferred Compensation Plan for Non-Employee Directors (RSDCP).
- (3) Total adjusted to reflect 50% stock dividend. As a result of the stock dividend the reporting person received 3,563,546 additional shares of PACCAR common stock.
