The Reporting Persons' percentage ownership of the Common Stock is based on 45,195,887 shares of Common Stock being outstanding and the ownership of 528,169 warrants (the "Warrants") by the Reporting Persons to purchase an equivalent number of shares of the Common Stock.

As of December 31, 2003, (i) BVF beneficially owned 180,569 shares of Common Stock, of which 160,211 shares are attributable to Warrants; (ii) BVF2 beneficially owned 114,163 shares of Common Stock, of which 101,233 shares are attributable to Warrants; (iii) Investments beneficially owned 256,986 shares of Common Stock, of which 241,197 shares are attributable to Warrants; and ILL10 beneficially owned 25,528 shares of Common Stock, all of which are attributable to Warrants. Beneficial ownership by Partners and BVF Inc. includes 577,246 shares of Common Stock, of which 528,169 shares are attributable to Warrants.
