Fractional shares of Kinder Morgan Management, LLC ("KMR") that were received by the Reporting Person as part of quarterly share distributions paid by KMR were maintained by his broker in a separate account. These fractional shares accumulated to 15.99 shares (1) owned by the Reporting Person. The purpose of this amendment is to include these accumulated fractional shares in the number of KMR shares reported in footnote (2) as being exchanged in the KMR merger. In accordance with Instruction 9 to Form 4, this amendment does not repeat lines of transaction information that were disclosed in the original Form and are not being amended.

Received in exchange for 43,763 shares of Kinder Morgan Management, LLC ("KMR") in connection with the merger of KMR with a (2) subsidiary of Kinder Morgan, Inc. ("KMI"). On November 26, 2014, the last trading day for the KMR shares, the closing price of KMR's shares was \$104.71 per share, and the closing price of KMI's Class P common stock was \$42.32 per share.
