The consummation of the conversion is subject to, among other things, the sale of the minimum number of shares offered and compliance with the conversion approval letters of the Illinois Office of Banks and Real Estate and the Federal Deposit Insurance Corporation.

At September 30, 2001, the Holding Company had no assets or liabilities and had not conducted any material operations.
