### ITEM 1.01 – ENTRY INTO A MATERIAL DEFINITIVE AGREEMENT

On January 21, 2015, Crown Castle Operating Company ("Borrower"), a direct wholly owned subsidiary of Crown Castle International Corp. ("Company"), entered into Incremental Facility Amendment No. 4 ("Incremental Facility Amendment"), among the Company, the Borrower, certain subsidiaries of the Borrower, the lenders party thereto and The Royal Bank of Scotland plc ("RBS"), as administrative agent, issuing bank and swingline lender, to the Credit Agreement dated as of January 31, 2012 (as amended, supplemented or otherwise modified, the "Credit Agreement"), by and among the Borrower, the Company, the lenders and issuing banks from time to time party thereto, RBS, as administrative agent, Merrill Lynch, Pierce, Fenner & Smith Incorporated, as syndication agent, and Morgan Stanley Senior Funding, Inc., as co-documentation agent. The Incremental Facility Amendment increased the aggregate revolving commitments under the Credit Agreement by \$630 million, such that the aggregate revolving commitments under the Credit Agreement after giving effect to the Incremental Facility Amendment are \$2.13 billion.

The foregoing summary of the Incremental Facility Amendment does not purport to be complete and is subject to, and qualified in its entirety by, the full text of the Incremental Facility Amendment, which is attached hereto as Exhibit 10.1 and is incorporated herein by reference.
